*All electrical equipment must be listed on the application (i.e. refrigerator, blenders, etc...). The Portland Windfest Committee will try to accommodate your electrical needs; however, there are limited resources.

All booths will receive four (4) Vendor Passes to enter the Windfest grounds and two (2) Vendor Parking Passes. (ANY EXTRA PASSES FOR ADDITIONAL WORKERS WILL NEED TO BE PURCHASED FOR \$2) Parking Passes are ONLY valid in Vendor Parking designated areas. This will be strictly enforced. The Portland Windfest Festival Committee (PWFC) will avoid to the best of our ability permitting two vendors to sell a similar food product. In the event of a conflict, the PWFC reserves the right to make the final decision. The vendor or organization holds the Portland Chamber of Commerce harmless in all respects. If you have questions regarding county requirements for temporary food licenses or food handler permits, you should call the County Health Department, (361) 364-6208, Option 2. Each booth is required to have a current 5 lb ABC Fire Extinguisher and this will be checked by the Portland Fire Dept. before opening. All booths are prohibited to close early. Designated times & dates for operation for all Food Booths are Friday, April 16 from 6pm until 10pm, Saturday, April 17 from 11am until 10pm and Sunday, April 18 from 12noon until 5pm. Ice may be purchased from the Drink Booth located on the festival grounds for \$3 per bag. Proof by copy of Permit / Licensing from the Health Department must be provided to the Portland Chamber no later than March 5, 2010 or vendor will be denied participation. Payment is non-refundable; no reimbursements to vendors will be honored.
