PARTICIPANT COMMITMENT FORM

Guidelines for Commitment:

Attendance is required so that attendees receive a meaningful experience from investment. Participants and their employers must be willing to commit the necessary time to fully participate in the program. To graduate, a participant is required to attend the mandatory Team Building retreat and all monthly sessions in their entirety. Participants must also commit time necessary to work with classmates on class project. While it is understandable that, on occasion, an absence is unavoidable, a participant may not miss more than one (1) class session and must complete additional enrichment activities to make up any missed time. Tuition is nonrefundable. Participants must be prepared to commit a full day to each scheduled session.

As a participant in the Leadership Portland program, I am willing and able to attend the sessions and programs organized by the Steering Committee of Leadership Portland.

I have studied the calendar of events and have determined that my schedule will permit me to participate fully. Since Leadership Portland is an educational program consisting of nine monthly meetings, an orientation/photo session, and a graduation event, I realize that it is essential that I attend all programs in their entirety.

I understand that any of the following may disqualify me from formal program completion and graduation:
